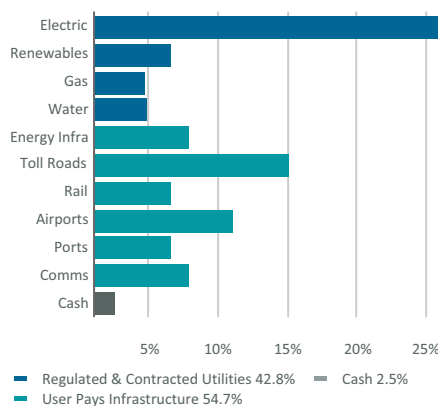

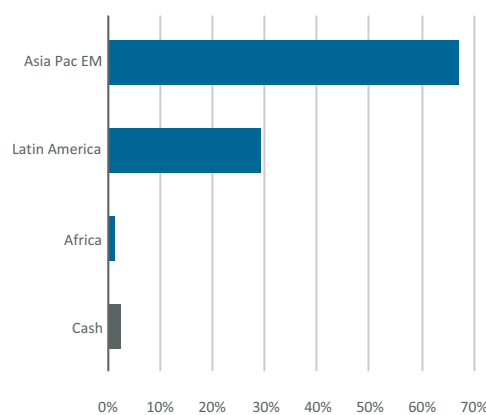

### SECTOR BREAKDOWN



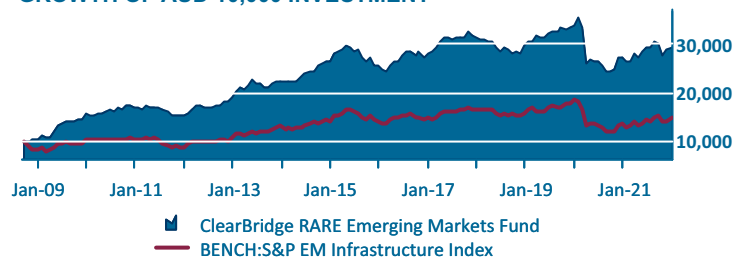

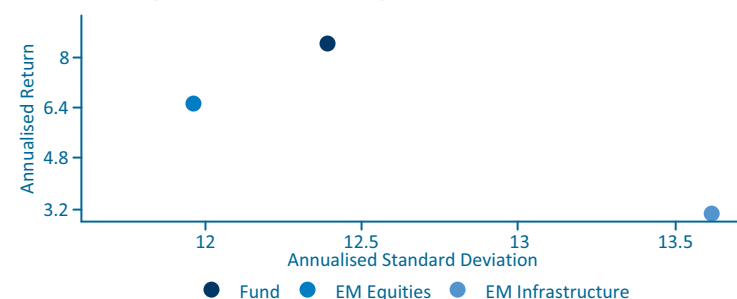
