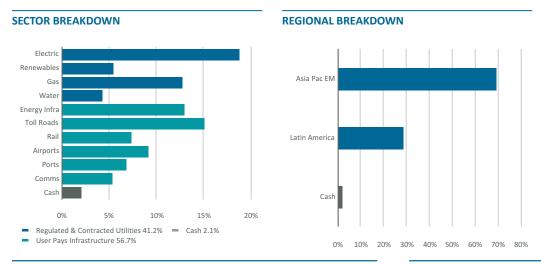


# ClearBridge RARE Emerging Markets Fund

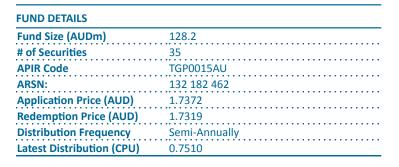

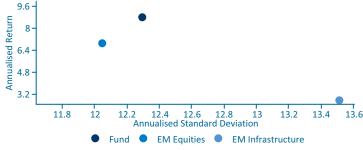
