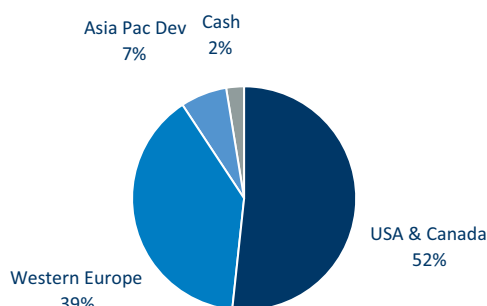
### OVERVIEW

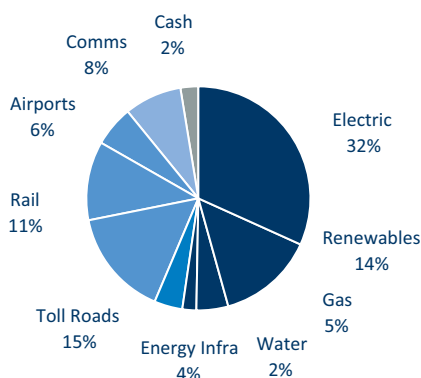

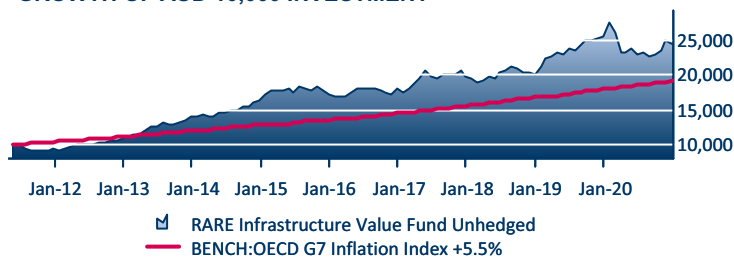

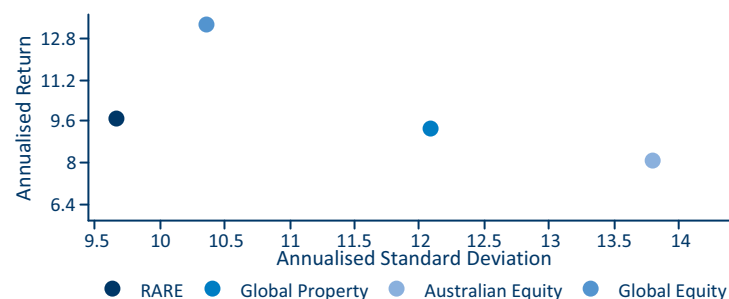
