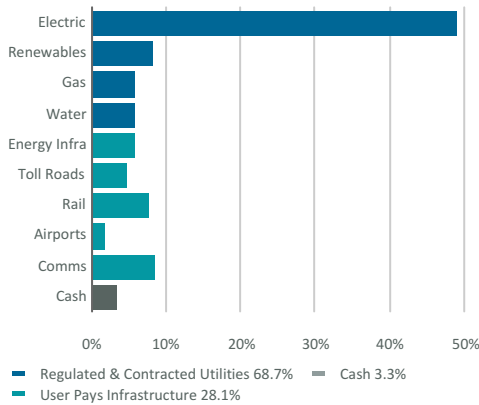

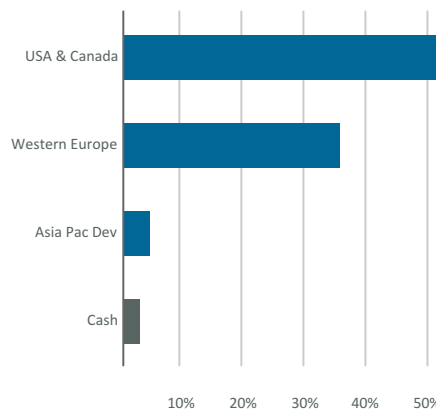

SECTOR BREAKDOWN



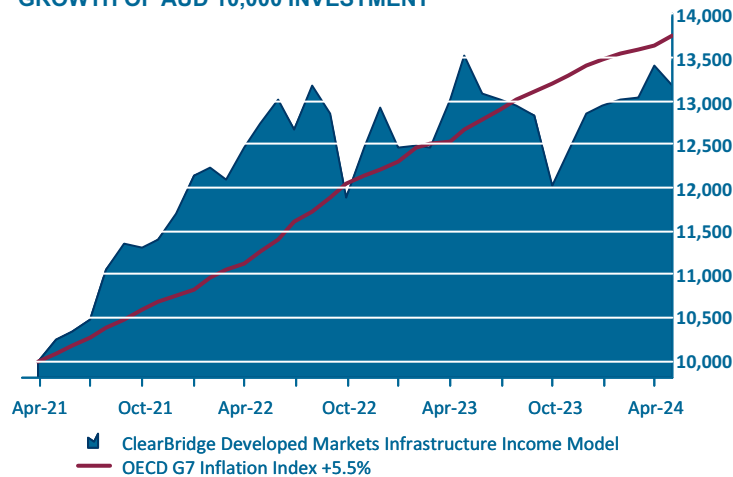
REGIONAL BREAKDOWN



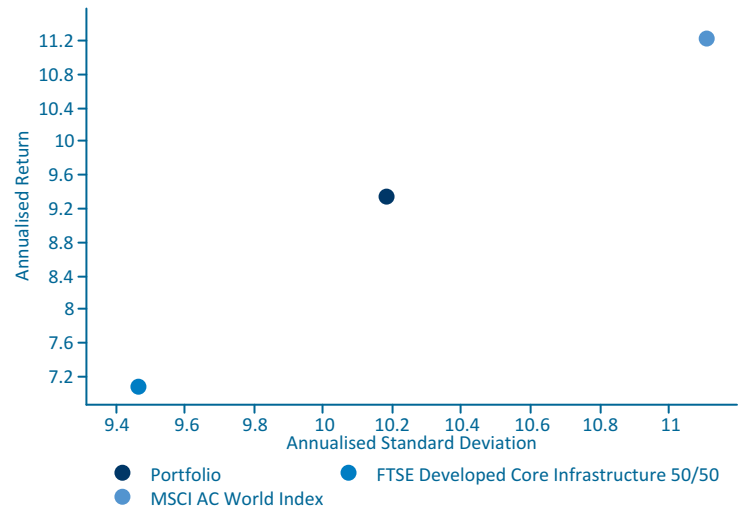
